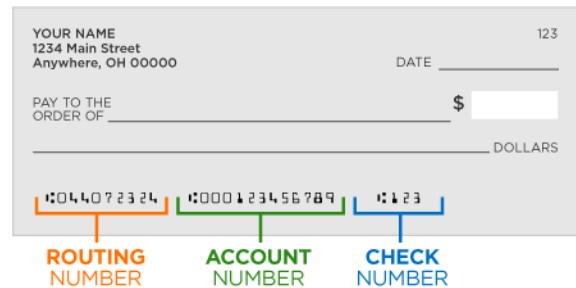

Save time and money with the Automatic Payment Plan by having your monthly rural water bill deducted from your checking account.

This FREE SERVICE is now available to all members of Osceola County Rural Water System, Inc. (OCRWS). Some benefits of the Automatic Payment Plan are:

- No more writing a check to OCRWS for your water bill. No more mailing costs.
- Your rural water bill will be paid on the due date – no more worrying about getting your check to our office on time.
- Accurate record keeping from your financial institution showing the direct payment you make to OCRWS on your bank statement.
- Privacy – on an average, ten people handle a check from the time it is written until the funds are transferred from your financial institution to OCRWS's financial institution.

Your financial institution automatically transfers the amount of your monthly rural water bill from your account to OCRWS each month. The amount transferred will also appear on your monthly bank statement.

The amount due will be transferred out of your account on the 20<sup>th</sup> of each month for payment of your rural water bill. Your monthly rural water bill will be mailed during the first week of each month indicating the amount that will be withdrawn from your account.

You can withdraw from this plan at any time by providing us with written notification. OCRWS reserves the right to cancel your use of the automatic payment plan.
